DRIVER CODE OF CONDUCT WORK SITE TRAFFIC CONTROL AT HITCHCOCK ROAD SAND PROJECTS MAROOTA

1.0 General Requirements

Drivers hauling VENM material to and process material from Hitchcock Road Quarry Site, (Lot 198 DP752025) Patricia Fay Drive Processing Site have undertaken a site induction carried out by an approved member of the construction management team of suitably qualified person,

- i) Hold a valid driver's licence for the class of vehicle they operate;
- ii) Operate the vehicle in a safe manner within and external to the quarry site;
- iii) Comply with the direction of authorised site personnel when within the site;
- iv) Adhere to the site speed limit of 20Km/Hr on haul roads within the site;
- v) Follow the directed traffic route and loading areas within the site;
- vi) Adhere to the designated transport routes Wisemans Ferry Road and Old Northern Road.

1.1 Heavy Vehicle Speed

Increased speed means not only an increased risk of crashing but also increased severity if an accident occurs. A study undertaken for the Australian Transport Safety Bureau found that travelling 10 km/h faster than the average traffic speed can more than double the risk of involvement in a casualty accident. (Source Roads and Maritime Services (RMS)).

There are two types of speeding: i) Where a heavy vehicle travels faster than the posted speed limit; and ii) Where a driver travels within the speed limit but because of road conditions (e.g., fog or rain) this speed is inappropriate. (Source RMS).

Drivers and truck operators are to be aware of the "Three Strikes Scheme" introduced by the Roads and Maritime Services which applies to all vehicles over 4.5 tonnes. When a heavy vehicle is detected travelling at 15 km/h or more over the posted or relevant heavy vehicle speed limit by a mobile Police unit or fixed speed camera, the Roads and Maritime Services will record a strike against that vehicle. If three strikes are recorded within a three year period, the Roads and Maritime Services will act to suspend the registration of that vehicle (up to three months). More information is available from the Roads and Maritime Services website.

The speed limit within the site is 20km/hr maximum. Drivers must adhere to the traffic speed signage within the site at all times.

Vehicle speed on public roads is enforced by the NSW Police Service. All heavy vehicle drivers operating out of the site are to observe the posted speed limits, with speed adjusted appropriately to suit the road environment and prevailing weather conditions, to comply with the Australian Road Rules. The vehicle speed must be appropriate to ensure the safe movements of the vehicle based on the vehicle configuration.

1.2 Heavy Vehicles Driver Fatigue

Fatigue is one of the biggest causes of accidents for heavy vehicle drivers. The Heavy Vehicle Driver Fatigue Guidelines -2007 by the National Transport Commission (NTC) are to be followed by all heavy vehicle drivers.

The heavy vehicle driver fatigue law commenced in NSW on 28 September 2008 and applies to trucks and truck combinations over 12 tonne GVM (however there are Ministerial Exemption Notices that can apply). Under the law, industry has the choice of operating under three fatigue management schemes: i) Standard Hours of Operation ii) Basic Fatigue Management (BFM) iii) Advanced Fatigue Management (AFM) All heavy vehicle drivers operating out of the site are to be aware of their adopted fatigue management scheme and operate within its requirements.

1.3 Heavy Vehicle Compression Braking

Compression braking by heavy vehicles is a source of irritation to the community generating many complaints especially at night when residents are especially sensitive to noise. In some instances, compression braking is required for safety reasons however when passing through or adjacent to residential areas a reduction in the speed of the vehicle is recommended to reduce the instances and severity of compression braking.

The site is located within a rural area and not near residential homes.

However, if a driver is to pass residential areas they are to ensure brakes are applied so as not to create excessive noise that could disturb local residents where possible.

1.4 Heavy Vehicle Noise

The operating hours for transportation of materials to and from the-site as stated in the Project Conditions under Schedule 2 Development Consent No 06_0104 S4.55(2) dated 3 December 2021 Condition 7 Table 2.

Notes:-

- Product transportation prior to 7.00am is restricted as per condition 8 of Schedule 2.
- Maintenance activities may be conducted outside the hours in Table 2 provided that the activities are not audible at any residence beyond the boundary of the site.
- This condition does not apply to delivery of material if that delivery is required by police
 or other authorities for safety reasons, and/or the operation or personnel or equipment
 are endangered. In such circumstances, notification is to be provided to the EPA and
 the Department and the affected residents as soon as possible, or within a reasonable
 period in the case of emergency.

1.5 Access to and from the Sites

The Hitchcock Road Sand Project Quarry site is accessed from the Wisemans Ferry Road and Patricia Fay Drive intersection to the east of Patricia Fay Drive. The start of the haul road entry is signposted on a tree in the photograph in Loading Procedure one – Pit 2.

1.6 Site Operations

The Safety Management procedure described in the Contractor Induction Form 36 prepared by P.F. Formation must be adhered to by all contractors vising or working on site.

The General Traffic Rules incorporated in the P.F. Formation Traffic Control Plan 2021 apply to the site and must be adhered to. The P.F. Formation TCP 2021 is included in Appendix A. The 20km/hr speed limit signs are not in place in Patricia Fay Drive and the haul road to Pacific Fay Drive but are to be installed by the Applicant.

All heavy vehicles transporting processed sand from the site must pass over the weighbridge and a docket. There is a tarp area for heavy vehicles that require manual tarping adjacent to the weighbride.

1.7 Load Covering

Loose material on the road surface has the potential to cause road crashes and vehicle damage. All trucks arriving at or departing from the site whether loaded with material or not are required to have an effective cover over their load for the duration of the trip. The load cover may be removed upon arrival at the delivery site. All care is to be taken to ensure that all loose debris from the vehicle body and wheels is removed prior to leaving the site. Drivers must ensure that following tipping, the tailgate is locked before leaving the site.

1.8 Breakdowns and Incidents

In the case of a breakdown the vehicle must be towed to the nearest breakdown point as soon as possible. All breakdowns must be reported to the RMS TMC (Transport Management Centre) on 131700 and the vehicle protected in accordance with the Heavy Vehicle Drivers handbook. To ensure that traffic impacts are minimised in the event of an incident, rapid response from the haulage company is required. In order to ensure rapid response to incidents drivers must contact the RMS TMC on 131 700, their shift manager and the Site Manager as soon as the stranded vehicle and load is safely secured. The Applicant must notify the Department in writing via the Department's major projects website and other relevant agencies immediately after it becomes aware of an incident.

If there is a product spill while loading/unloading or en-route the driver must:

- i) Immediately warn persons in the area who may be at risk;
- ii) Inform their shift supervisor/owner.
- iii) All spills must be adequately cleaned up and waste disposed of in an acceptable and environmental manner;
- iv) Put out warning triangles where it is safe to do so;
- v) Contact the NSW Police Service.



APPENDIX H

Maroota Local Traffic Management Policy

The Maroota Local Traffic Management Policy is an inter-pit agreement between local sand quarries.

Extractive industry operators and their customers benefit from the use of local and arterial roads, in particular Old Northern Road and Wisemans Ferry Road. These roads are shared between local residents, businesses, travellers and haulage vehicles.

As a licenced driver in the Maroota area you are aware of the existing local speed limitations and the speed restrictions at the Maroota Public School, along Old Northern Road.

All haulage vehicles entering and leaving the quarry sites <u>must comply with the Traffic Management Policy including</u>:

- The speed limit as observed on all local and arterial roads in the Maroota and surrounding areas,
- . The speed limit on Old Northern Road at Maroota Public School is 60 km/h
- The speed limit on Old Northern Road during school zone times is 40 km/h between the hours of:
 - o 8:00 9:30 am, and
 - o 2:30 4:00 pm
- · All loads must be covered before leaving quarry sites, and
- Drivers are requested to limit the use of engine / exhaust braking in considering potential noise impacts.

Repeated failure to comply with the Traffic Management Policy may result in refusal of entry to all quarries under this agreement.

The growing importance of Maroota sand resource as a valuable commodity for the Sydney sand market warrants a high standard of compliance and self-regulation to ensure our joint commercial future.
